6. Basketball

The number of teams from each school and any exception dates were given to Barry at the meeting. You have until October 15 to make any changes. After that date, fines will be assessed for any changes in the number of teams from your school.

The “data form” sheet, “request for transfers” form and “request for scheduling considerations” form (all signed by your principal) need to be given to Barry at the November meeting.

The team rosters and the basketball coaches’ information sheet need to be turned in at the December meeting.

The fee has gone up to \$350 per team. Basketball fees will be due at the November meeting.

Information about the Turkey Tournament will be on the website.

The Tulsa Tournament will be the first weekend in December. Only 7th and 8th grade teams may enter. All other grades will be starting the season with league games that weekend.

There will be one new rule this year. The rule will be that only players and coaches will be allowed on the basketball court. This includes in between games as well as during half time. We will vote on the rule at the November meeting.

After the rules are set and posted on the website, please make sure that copies of the rules are given to each coach and made available to all families who will have children playing on a basketball team. After reading the rules each coach needs to sign the rules sheet. This sheet is due at the December meeting.

The mandatory coaches meeting will be in November at John Carroll.

There will be a free coaches’ clinic at Mount St. Mary High School on Friday, October 12. It will be held in the gym and begin at 5:00 pm. All coaches are invited. Flyers about the clinic were handed out to the representatives at the meeting.
